PURCHASE AGREEMENT

Customer warrants the above information to be true and accurate. The customer hereby agrees that all purchases made from Certified Meat Products are subject the following terms and conditions.

1. If any amount due to Certified Meat Products is not paid in the said period, the Customer agrees to pay interest in the amount of 1.5% (18% per annum) of the delinquent balance which shall accrue from the day payment is due until paid.
2. In the event any payment made to Certified Meat Products is returned, rejected, or dishonored for any reason, including but not limited to insufficient funds, closed accounts, stopped payments, or payment disputes ("Returned Item(s)"), Customer shall pay Certified Meat Products a fee for each Returned Item.
3. The Customer understands and agrees that Certified Meat Products may cancel extension of credit, and/or discontinue deliveries at any time.
4. Certified Meat Products may, regardless of the terms stated on the invoices, require all outstanding amounts to be paid in full on demand in the event that sales to the customer are discontinued for any reason.
5. The Customer agrees that all transactions arising hereunder shall be governed and interpreted by the laws of the state of California. In the event that suit is filed to enforce payment of all sums due under this agreement, I/we agree to pay reasonable court costs and attorney fees. It is further agreed by parties hereto that this contract was executed in the county of Fresno, state of California, and that in the event suit is filed to enforce any terms of this contract, that the proper county of venue of the matter shall be the county of Fresno.
6. The Customer agrees to pay, in the event the account becomes delinquent, all Certified Meat Products attorney's fees associated with collection of the account plus all attendant collection costs whether litigation is initiated or not.
7. The Customer authorizes Certified Meat Products to inquire into and obtain from any bank, lending institution or credit reference, whether listed on the credit application or not, any and all information relating to Customer creditworthiness or financial condition.
8. The Customer Agrees that all sales are final. Acceptance of returned merchandise is subject to management approval.
9. This Agreement may be executed and delivered by electronic transmission which shall be deemed to be an original. The Parties further agree that any signature that is executed via DocuSign is valid as a true and genuine signature and is binding and enforceable as if it is an original signature.
